He also served for 10 years as senior vice president for HSBC U.S. Group and Midland Bank plc, which HSBC acquired in 1992. There, Mr. Candido served as an officer and Board member of one of the first “bad bank” entities (Bracton Corporation) and various other loan workout/asset recovery companies that managed a substantial portfolio of troubled loans and distressed collateral, including operating companies that were restructured and ultimately sold. At HSBC/Midland, he worked on numerous restructurings, both within and outside of bankruptcy, that involved such companies as Lee Panavision (movie camera and filters manufacturer), General Development Corporation (publicly-held real estate developer), Laura Ashley (clothing/home furnishings retailer), and a variety of real estate companies, including two hotel properties in Orlando, Florida.
